Definitions

The Client: The recipient of the service/s carried out by Sumantha McMahon or another representative of ANYA Hair, Make-Up & Beauty.

The Company or I: ANYA Hair, Make-Up & Beauty, Sumantha McMahon or another representative of ANYA Hair, Make-Up & Beauty.

The Event/Booking: Relates in principle to the date whereby the event, 'the wedding', 'the trial', for example, takes place.

Upon the booking of any services you (The Client) are agreeing to these Terms & Conditions.

Arrangements

- If parking at The Client's chosen venue requires paying or is permit restricted, arrangements must be made to ensure that the parking is paid for or provided, and I must receive details of this arrangement in writing in advance.
- It is essential for both Trials and Services that we **commence at the agreed time** to avoid any inconvenience to anybody.

• The Client will always be given an estimate of how long a service will take but it may vary in length if there are circumstances to cause this. The Client will always be advised if we deem that more time than previously agreed upon is required.

If The Client is more than 15 minutes late, then ANYA reserves the right to withdraw the service in which case you will still be required to pay the remaining bill and any expenses incurred. If the service is not withdrawn, The Client must be prepared for it to finish later than the original estimate.

Travel Expenses

There are no travel charges if the chosen venue is within a 5 mile radius of Weybridge, Surrey (KT13). For venues outside the 5 mile radius, a charge of 40p per mile will be made or if applicable, the cost of public transport tickets/taxi fares.

Trial

The Trial provides The Client an opportunity to try various looks.

- 50% deposit required to secure the date (separate for The Event or Booking)
- Remainder of the monies owed must be paid on the date of the Trial unless paid electronically in which case all monies must be cleared 24 hours prior to the Trial
- A Trial will last for a maximum of 3 hours

Please note that all deposits are non-transferable. Please see the cancellations section for associated information.

The Event/Booking

- 50% deposit required to secure the date for The Event/Booking on receipt of which you will receive confirmation of all the booking details
- Remainder of monies owed must be paid on the date of The Event/Booking unless paid electronically in which case all monies must be cleared 24 hours prior to The Event/Booking

Please note that all deposits are non-refundable and non-transferable.

Cancellations

- Trial's must be cancelled with at least 7 days written notice before the date of the Trial in which case the deposit will be refunded.
- The Event/Booking must be cancelled with at least 3 weeks written notice prior to The Event date. No deposits paid will be refunded.

• In the unlikely scenario of Sumantha McMahon or any other ANYA representative being unable to attend The Trial or The Event/Booking (due to unforeseen circumstances such as a bereavement, serious illness or a random act of God), we will in the first instance offer an alternative professional to carry out the booked services. If this is not possible and the booking needs to be cancelled, a full refund will be given to The Client. No

further compensation will be offered.

If the booking is directly affected by circumstances out of the control of Sumantha McMahon or any other representative of ANYA, where possible The Company will endeavour to rectify such situations. However, no compensation will be offered on The Company's part. It is strongly recommended you take wedding insurance to cover you against these situations.
